## Aggregate Transportation Company of the Year Award

### Aggregate Transportation Company of the Year Program

The *Aggregate Transportation Company of the Year Award* is presented annually by OAIMA (Ohio Aggregates & Industrial Minerals Association) to recognize outstanding service to the aggregates industry by a transportation company. As a respected and responsible leader in the transportation industry, this company's achievements in serving the aggregates industry in Ohio deserve special recognition. Companies nominated for this award exemplify the very best in their profession.

### Eligibility for Aggregate Transportation Company of the Year Award

The transportation company that is nominated must be actively involved in the aggregate transportation business in Ohio at the time of nomination.

The company must be nominated by a regular voting member of OAIMA.

The company must have been in the aggregates transportation business in Ohio for at least five (5) years.

### Selection Process

Nominations for the Aggregate Transportation Company of the Year Award will be submitted on a nomination form provided by OAIMA.

The nomination form will be completed by the nominator and submitted to the selection committee in order for a transportation company to become eligible for the Transportation Company of the Year Award.

Any employee of a member company of OAIMA may nominate one (1) company for the Transportation Company of the Year Award in any one year.

The criteria set for the selection process shall be the following: Fleet Safety Record (20%); Fleet Cleanliness and Maintenance (20%); Overload Record (20%); Service/Employee Attitude (20%); and Community Involvement / Neighborhood Relations (20%).

The selection committee shall be composed of the current OAIMA president; the OAIMA immediate past president; and the members of the OAIMA Safety Committee.

Nomination forms shall be distributed to the OAIMA membership in August each year and nominations will be due by early October 1<sup>st</sup>. The Aggregate Transportation Company of the Year Award will be presented by the OAIMA president at the OAIMA Annual Meeting Awards Brunch.
