Bylaws & Constitution

ARTICLE I - Name, Location and Objective

Section 1. The Ohio Aggregates Association shall do business as the Ohio Aggregates & Industrial Minerals Association ("OAIMA").

Section 2. The principal office of the OAIMA, unless otherwise determined by the Board of Directors (the "Board"), shall be in the Greater Columbus, Ohio area.

Section 3. Mission Statement:

The OAIMA shall:

- Represent all Ohio industrial minerals industries;
- Promote OAIMA's members' interests in the public and private sectors;
- Promote responsible regulatory compliance;
- Provide timely education, training, and communications; and
- Meet the evolving needs of OAIMA's membership.

In general, the OAIMA shall perform such acts and services for its members where industry, rather than individual, action is more effective.

ARTICLE II - Membership

Section 1. Any person, firm or corporation engaged in the production and/or sales of industrial minerals in the United States shall be eligible for membership as an Active Member in the OAIMA, subject to the approval of the Board.

Section 2. Any person, firm or corpora-

tion engaged in the manufacture or sale of equipment, materials or services used by the industrial minerals industry, or in the publication of trade, technical or other journals of interest to the industrial minerals industry, or members of technical and professional societies and organizations interested in the industrial minerals industry, shall be eligible for membership as an Associate Member in the OAIMA, subject to the approval of the Board.

Section 3. The Board shall have the power to prescribe rules and regulations for the admission of new members, which rules and regulations shall not be in conflict with the provisions of these By-Laws.

Section 4. Distinguished Life Membership: A Distinguished Life Member must be an individual who is a former officer, director, committee chair or committee member of the OAIMA, no longer associated with any member in recognition of the individual's past services to the OAIMA. Nomination for Distinguished Life Membership shall be initiated by the Board and must be approved by at least a four-fifths vote of the Board present at a regular meeting of the Board or at a special meeting called for the purpose of considering such a nomination. Distinguished Life Members are not entitled to membership privileges.

**ARTICLE III -
Budget**

Section 1. Dues for both Active and Associate members shall be determined by the Board and shall be based on the financial needs of the OAIMA.

Section 2. Annually, the Board shall adopt a budget covering activities of the OAIMA for the ensuing fiscal year. The fiscal year shall be established by the Board.

**ARTICLE IV -
Meeting of Members**

Section 1. There shall be at least one meeting of the membership of the OAIMA each calendar year. The Board shall fix the date and place of such meeting. The call of the meeting, stating the place and date thereof, shall be given to Active Members at least thirty (30) days prior thereto.

Section 2. Special meetings of the Active Members shall be called by the President upon request of a majority of the Active Members of the Board. The request shall specify the object of the special meeting, shall be given to the Executive Director, and notice given to Active Members at least twenty (20) days prior to the date of such meeting.

Section 3. At all duly called meetings of membership, Active Members shall be entitled to one vote, in person or by proxy (in person or in writing). Associate Members shall have the privilege of the floor, shall be entitled to enter into discussion of any question at an annual meeting or special meeting, but they shall not have the right to vote.

Section 4. At all duly called membership meetings, a quorum shall consist of 25 percent of Active Members present in person, or by proxy, who shall have the power by majority vote to act upon all matters properly before the meeting.

**ARTICLE V -
Directors**

Section 1. The Board shall consist of Thirteen (13) Directors affiliated with Active Members and three (3) Directors affiliated with Associate Members. To the extent that it is feasible, Directors shall be geographically distributed and shall be fairly representative of the Active Members. In no case shall one Active Member or its affiliates have more than one seat on the Board.

Section 2. The Board shall consist of the following:

- a. **Nine (9) Directors** to be elected by the Active Members for a period of three (3) years, on staggered terms.
- b. **Four (4) Directors** consisting of the active President, First Vice President, Second Vice President and Immediate Past President of the Association.
- c. **Three (3) Directors** to be elected by the Associate Members for a period of three (3) years, staggered terms. Ballots will be transmitted thirty (30) days prior to annual meeting. The results of the election shall be announced at annual meeting.

Any action by the Board shall be by majority vote, unless otherwise specified by these By-Laws. Failure to obtain a majority vote on any Board action shall mean that the measure did not pass.

Section 3. All Active Member Directors shall be eligible to serve two (2) successive terms but shall not be eligible for re-election until one (1) year after the end of the second term.

Section 4. The Board shall have the power to fill all vacancies occurring in the Active Member Directors, among the Executive Committee, and among the officers, caused by death, inability to act or resignation. Such vacancies shall be filled by a vote of the majority of the Active Members of the Board and such election shall be deemed to be only for the balance of the unexpired term. Directors appointed to fill a vacancy are eligible for two successive terms in addition to serving out the vacant term.

Section 5. The Board shall hold no fewer than two meetings each year, the time and place of such meetings to be determined by the Board. Special meetings of the Board may be called at any time, or shall be called by the President upon the request of fifty (50) percent of the Directors, but in either case, upon due notice as hereinafter provided.

Section 6. At any meeting of the Board, one-third of the Directors must be present in person, or by proxy in person (mail proxies are not allowed), to constitute a quorum for the transaction of business.

Section 7. Due notice, as used in this Article V, means notice at least ten (10) business days, prior to the meeting. Actual attendance at such meeting, or a waiver of notice before or after such meetings, shall be deemed to satisfy the requirements for due notice.

ARTICLE VI - Executive Committee

Section 1. The President, First Vice-President, Second Vice-President and the Immediate Past-President of the OAIMA shall constitute the Executive Committee.

Section 2. At any meeting of the Executive Committee, action shall be by a majority. Three (3) members shall constitute a quorum and members may participate and vote in person, by phone or by electronic media.

Section 3. The Executive Committee shall meet at the call of the President or upon request to the President by a majority of the Executive Committee.

ARTICLE VII - Administration

Section 1. The Executive Committee shall have and exercise the powers of the Board between the meetings of the Board, subject to any prior limitations established by the Board. All action of the Executive Committee shall be reported at the next meeting of the Board and shall be deemed ratified unless the Board acts otherwise.

Section 2. The President shall have the right, whenever in his judgement the circumstances require immediate action, to submit questions involving OAIMA policy to the Directors or to the Executive Committee. The results of such request shall have the full force and effect of a formal consideration at any regularly called meeting of the Board.

Section 3. As used in this Constitution and By-Laws, any notice, ballot, or ques-

tion to be presented to the Membership may be given by regular U.S. Mail, electronic mail, or facsimile. "Membership" or "Member" means any Active Member or Associate Member as the context requires.

ARTICLE VIII - Officers

Section 1. Officers of OAIMA shall consist of the President, First Vice-President, and Second Vice-President. Officers shall be elected by the Active Members at the annual meeting and shall hold office for one year beginning upon adjournment of the annual meeting, so electing them and ending upon the adjournment of the annual meeting of the next succeeding year, or until their successors shall have been duly elected. Officers shall have had previous Board experience. Officers are eligible to hold office for two consecutive terms.

Section 2. The President shall preside at all meetings of the Board, the Executive Committee, and of the membership. The President shall appoint, subject to the approval of the Board, committees of the OAIMA. The President shall be an ex-officio member of all committees except the Committee on Nominations. The President shall perform such other duties as may be delegated to him by the Board or by the Executive Committee.

Section 3. The Vice President, in the absence or disability of the President, shall act for the President with the full authority granted in Section 2 hereof.

Section 4. The Treasurer shall be appointed by the Executive Committee and confirmed by the Board. The Treasurer

shall participate in the annual budget conference and review the annual audit report. Treasurer shall assume a major role in financial discussions at meetings of the Board and Executive Committee and shall provide to the Board, as requested, an accounting of the finances of OAIMA. The Treasurer shall serve at the pleasure of the Board.

Section 5. The Board shall appoint an Executive Director who shall be the principal executive officer of the OAIMA. The Board may authorize the appointment of such other staff personnel as is necessary to transact business. Compensation for the staff shall be determined by the Board upon the advice and recommendation of the Executive Committee.

Section 6. In addition to other duties, the Executive Director shall be responsible, with appropriate staff assistance, for recording and preparing the minutes of all meetings of the members, the Board, the Executive Committee, and the committees and sub-committees. The Executive Director shall be responsible for signing all checks and may delegate this duty to the Treasurer and staff as authorized by the Board. All staff shall be bonded at the expense of OAIMA.

Section 7. Members of the Board, the Executive Committee, committees and sub-committees, and Officers shall serve without compensation.

**ARTICLE IX -
Committee on Nominations**

Section 1. The Committee on Nominations shall consist of three (3) Directors, appointed by the President, with the advice and consent of the Board. The Committee shall by majority vote select a chairman.

Section 2. The Committee shall submit nominations to the Membership at least thirty (30) days before the annual meeting for three (3) Directors for election at the annual meeting. Committee shall also submit nominations for three (3) officers to be elected at the business meeting of OAIMA at the annual meeting. In making these nominations, the Committee shall observe the guidelines set forth in Article V, Section 1.

Section 3. At least thirty (30) days prior to the annual meeting, the Associate Members shall submit Associate Member name(s) to be placed in nomination for election of the Associate Director. Ballots will be provided within (15) fifteen days of the Annual Meeting with the results of the election to be announced at the annual meeting.

**ARTICLE X -
Parliamentary Procedure**

Section 1. Roberts' Rules of Order, Revised, shall be the standard authority for the conduct of all meetings.

**ARTICLE XI -
Amendments**

Section 1. This Constitution and these By-Laws may be amended at any meeting of the membership by a vote of two-thirds of the Active Members present and voting. Notice of any proposed amendment shall be furnished to the membership in writing at least thirty (30) days before the meeting at which such amendment is to be voted upon.

**ARTICLE XII -
Status of Assets and Liabilities**

The disclosed assets and liabilities of the OAIMA as originally constituted shall be and remain the assets and liabilities of the Association as re-constituted by the Adoption of this Amended Constitution and of these Amended By-Laws.

**ARTICLE XIII -
Committees**

Section 1. Standing and special committees may be established by the Board or by the President with the consent of the Board, at any time with specified authority and responsibilities.

Section 2. The Board may appoint from the membership task groups for the purpose of dealing with uncommon situations. Such groups shall report back to the Board with recommendations, if any, for appropriate Board action.
